#### HIV/AIDS Epidemic Update: India and Global




- NACO under the aegis of Ministry of Health and Family Welfare, Government of India (GoI) implements NACP
- NACP is the World's largest and most comprehensive HIV programme

Indicator	Global (2021)	India (2022)
People living with HIV (All ages)	38.4 million	2.4 million
New HIV Infections (All ages)	1.5 million	66,400
PLHIV on ART	28 million*	1.7 million**
AIDS-Related Deaths	.6 million	39,600

- ✓ Low Prevalence Country (Adult Prevalence=0.20%)
- ✓ 2<sup>nd</sup> Largest No. of PLHIV in the world
- ✓ Female: 45% of PLHIV; Children: 2.75% of PLHIV

#### Way Forward



- Building greater coordination between related Ministries/Department and States to address the response
- Increase coverage of adolescent/ underage TG population (below 18 years sexually active TG) through interventions
- Awareness generation on issues/ challenges of Transgender persons, Sex and Sexuality and Transgender Act
- Reaching out to hidden and unreached population which are operating through virtual platform
- Exploring substance use and other associated risk behaviour of TG population
- Reduce stigma and discrimination in health care settings
- Leverage partnership with private sectors
